



2009 Leadership Forum Will Continue Discussion of Attracting, Retaining Next Generation of GEAPS Leaders

Last year at the Leadership Forum in Kenner, La., GEAPS leaders began the process of strategically looking forward—to identifying, developing and engaging the next generation of GEAPS volunteer leaders. With the assistance of a focus group comprising young grain company employees, members received answers to questions about finding, educating and retaining successors to lead both the association and the industry as a whole.

This year, GEAPS leaders will gather in Minneapolis, home to the GEAPS office, to pick up where they left off, look back on a year of progress, and evaluate next steps. Members will meet July 8 for the Leadership Forum, the centerpiece of the annual three-day Leadership Conference. The Conference will also feature a workshop and database training for chapter leaders and meetings of the International Board and Membership Committee.

"Last year's Forum gave us a lot to think about," said GEAPS International President Buzz Tourangeau. "Over the past year we've worked hard to engage the next generation and lay a strong foundation for GEAPS' future. This year, we'll measure how far we've come and plan where we go from here. This is an important topic, and one worth revisiting as we move forward."

The Forum will serve primarily as a day-long brainstorming session. Ideas and solutions that emerge will be considered for possible action the next day (July 9) by the International Board.

Registration for the Leadership Conference will open Monday, June 8. Read on to find out about travel reimbursement, hotel reservations and more.

Leadership Conference- Membership Meeting

The membership meeting at this year's Leadership Conference will focus on plans and/or changes for the 2009-10 member retention campaign as well as results from the 2008 retention program. The campaign—a collaborative effort between the Membership Committee and the local chapters—is an attempt to retain 2008-2009 members who have not renewed their memberships this year. Chapter officers do the bulk of the work by calling everyone in their chapter who did not renew their memberships, but Membership Committee oversight is essential for the program to work.

How the Member Retention Campaign works:

1. Everybody on the Membership Committee is assigned to oversee the program at one or more chapters.
2. The Membership Committee members call chapter presidents at their assigned chapters to introduce themselves and go over the program.
3. GEAPS will send each chapter president and vice president a list of everyone in their chapter who hasn't renewed, so the calls can be made.
4. The chapter officers call everyone in their chapter who has not renewed.
5. The Membership Committee members stay in touch with their assigned chapters to ensure that the calls are made. It's important to touch base with your chapters throughout the campaign. This is a collaborative effort between the Membership Committee and the chapters!
6. The chapters send us the results, and we follow up whenever appropriate.
7. Staff liaison Amy McGarrigle is available as needed for support.

Travel Reimbursement Funds Available To Chapter Members

GEAPS members designated by their chapters to attend the 2009 Leadership Forum in Minneapolis have the opportunity to have some or all of their travel-related expenses reimbursed via the GEAPS Leadership Development Program.

The Program was created to encourage chapter officers or other chapter leaders to attend both the Chapter Leader Workshop (July 7) and Leadership Forum (July 8) by covering costs associated with travel to the conference location.

The three-hour Chapter Leader Workshop will cover various topics essential to managing and leading your chapter in the most effective and efficient manner possible.

To qualify for the Leadership Development Program reimbursement funding, you must:

1. Be a designated representative of your chapter.
2. Be a paid GEAPS member (Associate or Regular) in good standing.
3. Attend both the Chapter Leader Workshop and the Leadership Forum.
4. Have your employer's approval for the time away from the job.

The Leadership Development Program funding is deducted from a chapter's EPPI money. Up to \$500 maximum can be applied to the cost of travel to the summer Chapter Leader Workshop and Leadership Forum. If the cost of travel is less, only the actual travel is reimbursed. If the cost of travel is more, then the traveler or chapter is responsible for the overage. More than one chapter leader may attend the Chapter Leader meeting and simultaneously use the funding, however, the total amount does not change.

Star of the West Milling Co. Plans \$3.7M Expansion at Frankenmuth, Mich. Facility

FRANKENMUTH, Mich. — Star of the West Milling Co. is beginning a multi-phase expansion of its Frankenmuth, Mich., facility this month in response to consumer demand for more grain-based foods. Additions will allow for an increase in production to 30,000 bushels a day, or 1.8 million pounds, of 10 to 12 products, including clean wheat, flour bran and wheat germ. Current production is 22,000 bushels, or 1.32 million pounds, per day.

Arthur A. Loeffler, company president for 11 years, said the expansion was necessary because of constant growth in the industry.

"The flour industry was hurt by the Atkins craze," he said, referring to the low-carb, high-fat diet. "But even then we were growing at a 2 to 3 percent rate each year. Last year, it was up 9 percent." Loeffler noted the jump is because

of a bigger demand for whole grain items, including bread and bran cereals.

Gary E. Pickelmann, corporate milling superintendent, said the construction will occur in four stages.

First, three storage bins—two for bran and one for wheat—each measuring 65 feet tall, will go up. A second stage will make room for an 85-foot-tall cleaning house, to prepare wheat for milling. A third component calls for a 25- to 30-foot-tall pre-cleaning area. The fourth stage includes two roller mills, airlock benches and conversion of sieves and sifters inside the existing milling area.

Additions are not new for the company. Star of the West has expanded from one to five mill sites since its inception by the Hubinger family in 1870, including Frankenmuth; Quincy; Ligonier, Ind.; Kent, Ohio; and Churchville, N.Y.

The business also has five elevators in the state. Star of the West also runs bean collection sites in Gera, Reese and Fairgrove and one site in McCanna, N.D.

Star of the West has 51 employees in Frankenmuth and 205 full-time employees company-wide. In 2008, the business totaled \$376 million in sales to 275 customers and was the 15th-largest milling company in the U.S., with a storage capacity of 14 million bushels.

Loeffler, who also serves as Frankenmuth's mayor pro tem, was happy to see the business provide some growth in the community.

"You look at the economy, and notice about all the bad things going on," he said, noting that construction growth in the city had slowed as of late.

"It will be nice to see some growth in the area," he said.

Gavilon Expands Presence In Indiana With Transfer Of Three Facilities

OMAHA, Neb. — Gavilon Grain, LLC and Ceres Solutions, LLP announced this month that the two companies have begun lease negotiations to transfer the operation of three Ceres-owned elevators to Gavilon, with an expected effective date of July 1, 2009, that is subject to change.

The lease arrangement of the elevators,

located in Whitesville, Cherry Grove and Pleasant Ridge, will expand Gavilon's presence in Indiana. Gavilon currently operates seven grain elevators in the state.

"This broader base of grain facilities will increase the strength of Gavilon's grain handling and distribution operations and contribute to its ability to compete more effectively in the Indiana market," said Greg Konsor, vice president and

general manager of Gavilon's grain operations.

Gavilon intends to retain all of the current grain employees at the three facilities, pending the completion of the application and hiring process. In addition, all existing contracts with the elevators will be honored. Konsor said the intention is to create a relatively seamless transition, allowing business activity to continue uninterrupted for the local customer base.

Germany: No Plans for Further Bans on GMOs

Germany's agriculture minister, Ilse Aigner, has said that the country has no plans to further restrict imports of EU-approved genetically modified (GM) food and feed products after banning the growth of a biotech maize last month.

"All things that we import have been approved [at EU level] and we're not going to look at that again," said Aigner.

"This was just about one maize variety, where we had a study suggesting it was a danger to the environment," she said of Mon-

santo's MON810 maize in interview during a meeting of farm ministers in Italy.

Germany is the sixth country to do so after France, Austria, Hungary, Greece and Luxembourg. Germany's ban on MON 810 maize means farmers will be unable to sow the crop for this summer's harvest.

MON 810 first gained EU approval for growing in 1998 and its license is currently under review for a renewal. The biotech maize so far is the only authorized cultivar within the 27 countries of the European Union.

However, there are a number of approved EU imports of GM products grown outside the EU-27, mostly for use in food and animal feed. Some of those products have also been subject to national bans, which a country may impose under EU law if it can justify scientifically invoking what is known as a "safeguard clause".

"We have a labeling provision in Germany for animal products," Aigner said. "We do import GM feed stuff but we want to make sure that consumers have choice through that label."

EPC to Plan Education Program, Pods at May Meeting

GEAPS' Educational Programming Committee will be in Minneapolis May 28 to begin preparing for Exchange 2010. The EPC develops the Exchange educational program from the ground up, starting at a May meeting every year.

The first step this year will be to sort through more than 135 suggestions for session topics that members and others have provided to the committee. The suggestions vary widely, but focus mostly on key issues relating to grain operations and related fields.

"We have a lot of work to do, but we come into the May meeting with one major goal," said EPC Chair Kathy Reading, Seedburo Equipment Co, *Cornbelt Chapter*. "We've got to select the topics that we'll pursue for the Exchange. Once we have that accomplished, we go out and find the best speakers available."

The EPC will also continue planning for equipment-related educational sessions, the curtained-off "pods," in the Exchange Expo Hall. At Exchange 2010, set for Feb. 20-23 in Wichita, the pods will feature dust-control equipment, allowing participants up-close, hands-on learning opportunities. EPC Vice Chair Ken Schmenck, The Andersons, Seaway, has taken the lead organizing the pod program.

The GEAPS Exchange education program is the largest in the grain industry. Next year, it's likely to cover more than 30 hours and include more than 50 expert speakers from around the world. The EPC organizes every facet of the program.

Reading said having veterans on the committee makes the job easier. "Turnover on the Committee is inevitable, so we have some new people every year. But we also have

GEAPS Forms Online Education Workgroup, Explores On-Demand Classes

"To fulfill our role as 'the knowledge resource' for this industry, it is very clear that we need to expand online educational services" said Buzz Tourangeau, GEAPS International president. "To make it work, we really need input from our members."

The group will address issues such as whether and how GEAPS should produce

webinars, post courses on the Web site, or offer similar educational programs that people could access online. The workgroup will develop an outline of an online program, determine its scope and purpose, and investigate how it might collaborate with GEAPS' existing education programs.

Later this summer, the workgroup will make recommendations to the International Board at GEAPS' Leadership Conference in July, and when finished, disband. If needed, a new "Online Education Oversight Committee" would then be formed to carry out the work group's vision.


New 2009-2010 DirectaSource On the Way

The new 2009-2010 *DirectaSource* is currently at the printer and should be arriving as soon as possible in your mailbox.




