# Rules of the Contract for GEAPS Exchange 2026 Exhibit Space

The undersigned exhibitor agrees to rent and occupy trade show booth space, as shown on the official floor plan, from the Grain Elevator and Processing Society during the Exchange 2026 exposition. The undersigned further agrees to abide by the rules and terms stated below, and to pay a rental fee in US dollars: at least half as a down payment by October 30, 2025, and the remainder on or before December 1, 2025. The undersigned also understands the requirement that each exhibiting company must employ at least one GEAPS member, or the price increases by \$2.00 per sq. ft.

#### 1. What the Rental Fee Includes

The rental fee paid for exhibit space is for space only and **does not include** carpet, furnishings, receiving or handling of exhibit material, or other services. Exhibit space includes back and side drape, and a uniform identification sign. Exhibitors will furnish any other items they wish to have in their exhibit space.

#### 2. Payment, Termination and Refunds

Exhibitors must make payment of the exhibit space rentalfee according to the schedule and terms described at the beginning of this contract. GEAPS may terminate this contract at any time after December 1, 2025, if an Exhibitor has not paid the total fee for space rented. Refunds for exhibit space will not be given after December 1, 2025 unless special circumstances occur. In the event that the show is physically sold out (there is no room for expansion) and there is an established waiting list, refunds will be given on a 1:1 basis less 10% of the rental fee paid for that particular space. The refund will only be given if the space is rerented. In the event of a cancellation, exhibitors must notify GEAPS in writing. If an Exhibitor has rented a dedicated island of 20'x20' or larger and wishes to cancel, the cancellation applies to the entire dedicated island space. An Exhibitor cannot cancel portions of a dedicated island space and retain the remaining square footage.

### 3. Occupation of Exhibit Space

Exhibitors will occupy their contracted exhibit space during the entire exposition. No early tear-downs are permitted. No subletting of any part of an Exhibitor's space is allowed, including subletting to distributors or other companies affiliated with the Exhibitor. No rights under this contract may be assigned without GEAPS' written consent. If an Exhibitor fails to occupy their contracted exhibit space, GEAPS will have the right, without notice, to occupy that space in the manner GEAPS deems best for the exposition, and the Exhibitor will be liable for any loss suffered by their failure to occupy the space.

#### 4. Relocation

GEAPS reserves the right to relocate any Exhibitor in space other than that for which the Exhibitor contracted and paid a rental fee, if GEAPS determines it is in the best interest of the exposition. However, GEAPS will only make a change of location after discussion with the Exhibitor who is being moved.

### 5. Suppliers of Exposition Services

GEAPS will select a general contractor and other suppliers to provide exposition services. A manual will be sent to Exhibitors containing forms and instructions for renting exhibit furnishings and services from the suppliers selected by GEAPS. Exhibitors will use these suppliers for all furnishings and services needed, including utilities; or Exhibitors will notify GEAPS, in writing, at least 30 days prior to setup of the exposition of their intention to use other suppliers; Exhibitors will obtain GEAPS' written authorization before using other suppliers.

#### 6. Exhibit Material, Activity, Noise and Air Compressors

Exhibitors will display only products or services directly applicable to the handling, storing or processing of grain or grain products, and display only products their own companies manufacture or sell. Booth

attractions/activities (e.g. shoe-shine stations, chair massage, costumed characters, etc.) unrelated to the exhibitor's line of business are permitted as long as they are confined to the exhibitor's rented exhibit space and do not impede on another exhibitor's ability to conduct business. GEAPS reserves the right to prohibit or remove display material, booth attractions, or activities, which in GEAPS' judgment detracts from the exposition. GEAPS reserves the right to restrict any exhibit, which, due to noise or other reason, is objectionable to GEAPS. Voice amplifiers for live demonstrations will not be allowed. In addition, if an exhibitor wishes to use compressed air, it must be purchased through the convention center if it is available. If compressed air is not available through the convention center, exhibitors may bring or arrange for their own bottled air if allowed by the facility. The cylinder must be appropriately contained. Exhibitors are not allowed to use air compressors in their exhibit space. GEAPS also reserves the right to prevent any Exhibitor from displaying beyond the bounds of the Exhibitor's rented exhibit space, either inside or outside the exposition facility.

#### 7. Sizes and Placement of Display

Exhibits must be set in line with the Exhibit Design Rules attached to and made part of this contract.

#### 8. Serving Refreshments

Exhibitors are permitted to provide food and non-alcoholic and alcoholic beverages in their booth spaces consistent with the following GEAPS and facility management policies:

Exhibitors must order all food & non-alcoholic beverages to be served in their booths through one of the exclusive convention center cateriers. Substantial food offerings that would be classified as heavy appetizers or a meal may only be served during the times listed below.

Alcohol may be ordered and served through the official Kansas City Convention Center caterer, Aramark, during the times listed below.

Substantial food offerings and alcoholic beverages may only be served during the following times:

Sunday from 1:00 - 4:00 pm Monday from 1:00 - 5:00 pm Tuesday from 12:00 - 1:30 pm

# 9. Cooperation with Union Rules

Exhibitors will cooperate with union employees and union rules whenever exposition services and activities are governed by them.

#### 10. Cooperation with Municipal and Facility Rules

Exhibitors will cooperate with all rules of the local police, fire department and other municipal authorities in the city where the exposition is held. In addition, Exhibitors will cooperate with all rules of the facility in which the exposition is held.

## 11. Damage to the Exposition Facility

Exhibitors will not damage the exposition facility in any way or permit it to be damaged by any substance or activity. If any Exhibitor, or the Exhibitor's agents, employees or guests, cause damage to the exposition facility, the Exhibitor will pay Exposition Facility Management the amount necessary to restore the facility to the condition it was in before being damaged by the Exhibitor.

## 12. Security

GEAPS will employ a security firm to guard the exposition hall against theft or damage to exhibit material.

### 13. Assumption of Risks: General Liability Insurance

Each Exhibitor MUST provide a Certificate of Insurance evidencing Commercial General Liability insurance. Certificates must be sent to and received by Grain Elevator and Processing Society (GEAPS) by December 1, 2025. Not providing a Certificate of Insurance will exclude the exhibiting company from participating in GEAPS Exchange 2026. Please note that Commercial General Liability Certificates of Insurance must show the following: Single Limit of liability in the amount of \$1,000,000 per occurrence. The Additional Insureds should be listed as Grain Elevator and Processing Society (GEAPS) and the City of Kansas City, Missouri. Exhibitor assumes risk associated with, resulting from or arising in connection with Exhibitor's participation or presence at the Exhibition, including, risks of theft, loss, harm or injury to

the person (including death), property, business or profits of Exhibitor, whether caused by negligence, intentional act, accident, Act of God or otherwise. Exhibitor has sole responsibility for its property or any theft, damage or other loss to such property (whether or not stored in any courtesy storage areas), including any subrogation claims by its insurer. The exhibitor agrees to carry appropriate insurance to cover these risks. Neither Grain Elevator and Processing Society (GEAPS) nor the Exhibit Facility accepts responsibility, nor is a bailment created, for property delivered by or to the Exhibitor. Neither Grain Elevator and Processing Society (GEAPS) nor the Exhibit Facility, nor any of their respective officers, directors, shareholders, employees, representatives or assigns, shall be liable for, and Exhibitor hereby releases all of them from, and covenants not to sue any of them with respect to, risks, damages and liability described in this paragraph.

#### 14. Cancellation of the Exposition

In the event the exposition is cancelled for any reason, GEAPS will not be liable for anything except the return of the rental fee paid by each Exhibitor for exhibit space.

#### 15. Enforcement of Contract Rules

GEAPS and its designated representatives will have the power to enforce the rules of the contract established herein and may from time to time establish additional rules. Consequences of not conforming to the rules of the contract after being asked to make a modification to comply: The Exchange general services contractor at the contractor's discretion in consultation with the GEAPS Exchange Exhibitor Services On-Site Committee will modify or remove the exhibit display and at the exhibitor's expense. Additionally, the IEC reserves the right to revoke the exhibitor's "priority-list" position [lose all accumulated priority credit to date.] The GEAPS designated Expo On-Site Committee at its discretion and by consensus of the committee, may deviate from these penalty quidelines.

# **Exhibit Design Rules**

These rules supplement the Rules of the Exhibitor Contract. GEAPS does not allow you to erect displays that interfere with other exhibits, or detract from the expo. Follow these rules and the contract rules as you plan and set up your exhibit.

# **Ceiling-Suspended Signs**

Banners or signs suspended above your booth must be finished and neat on all exposed sides. Their bottoms must be at least 11 feet off the floor, and their tops may be no higher than 16 feet off the floor. Their width, depth and diameter may not exceed the width or depth of your floor space.

You must use the designated form in the online exhibit kit to submit your plans for a ceiling-suspended banner or sign. GEAPS official exposition services contractor will hang all such banners and signs, and exhibitors are responsible for all costs associated with them.

# \*Height of Signs, Graphics and Background Displays

Background displays and graphics up to 8 feet in height may be installed in your exhibit space out to a distance of 5 feet from the back wall of the space. Beyond a distance of 5 feet from the back wall, backgrounds and showcases may be no more than 4 feet high. Unfinished sides or backs of showcases must be covered neatly.

\*This specific rule applies to signs, graphics and display assemblies (e.g. popup displays/showcases/backgrounds), and not equipment or other products or, physical representations (mock-ups) of equipment or products that are for sale. However, display lighting fixtures that are attached to the display may extend up to 6 inches above the display provided that the total display height does not exceed 8 feet 6 inches at any point.

# **Height of Products**

The height of equipment, products or physical representations (mock-ups) of equipment or products that are for sale is limited only by the ceiling and building regulations. However, starting 5 feet from the back wall and moving out toward the front, no products or equipment may stand within 12 inches of the siderails.

#### **End Cap Booths**

Exhibits set up perpendicular to the expo's numbered aisles—horizontally across the end of an island—have special requirements. Their 8-foot backgrounds or showcases may be no more than 10 feet wide, and must be centered on the 20-foot back edge of their space.

#### **Island Booths**

(Stand-alone representing a single exhibitor with aisles on all four sides.)

No height restrictions for products, signs, graphics and background display beyond the maximum height allowed by the convention center.

The exhibit hall floor load is 300 lbs per sq. ft. in Halls C, D, and E. In Hall B, the floor load is 200 lbs per sq. ft.

The ceiling height in the expo hall varies from 33' to 42'

#### **Exhibitors Must Work Inside the Booth**

**Note:** No exhibit or exhibit component will be allowed where the exhibit design intends or result requires that business, including demonstrations, be conducted in the adjacent aisle(s).

#### **Exhibit Diagram Submittal Requirement**

Exhibitors planning to include structures taller than 16' and/or physical enclosures as part of their exhibit must submit plans to GEAPS and the Exchange General Service Contractor in advance for review.
